Gift Aid Declaration

If you are a UK taxpayer, choosing to Gift Aid a personal donation will increase its value by 25% at no extra cost to you. And, if you pay tax at a rate higher than the basic rate, you can claim tax relief on the difference between your rate and the basic rate.
